Summary of Policy Topic

This Privacy Policy governs the manner in which Richey May & Co., LLP collects, uses, maintains and discloses information collected from individual usage of the http://www.richeymay.com and www.richeymay.com and www.richeymay.com and all products and services offered by Richey May & Co., LLP and Richey May Technology Solutions (collectively "RMC") are committed to the protection of the privacy of our clients' information.

"Site" means all websites including www.richeymay.com, or www.richeymaytech.com interactive features, widgets, plug-ins, applications, content, downloads and other electronic services maintained by any of the RMC or family of companies.

- "we," "us," "our," or "RMC," as used on this Site, mean the RMC and RMC family of companies.
- "you" or "your" mean you as an individual and, if you are an employee or representative of another person or entity, such person or entity.

Please review the Terms of Use. The Terms of Use governs your use of the Site. By using the Site, you agree to this Privacy Policy and the Terms of Use. You also agree to our collection, use, disclosure and storage of your information as described by this Privacy Policy. This Privacy Policy does not apply to the following.

PERSONAL IDENTIFICATION INFORMATION

We may collect nonpublic personal identification information from individuals in a variety of ways, including, but not limited to, when individuals visit our site, register on the site, subscribe to the newsletter, respond to a survey, fill out a form, and in connection with other activities, services, features or resources we make available on our Site. WEB BROWSER COOKIES

- To personalize user experience; We may use information in the aggregate to understand how our individuals as a group use the services and resources provided on our Site.
- To improve our Site; We may use feedback that is provided to improve our products and services.
- To run a promotion, contest, survey or other website specific feature; To send nonpublic information they agreed to receive about topics we think will be of interest to them.

In all such situations, we stress the confidential nature of information being shared and that they are bound either by our professional standards of confidentiality or nondisclosure agreements where applicable.

In addition, these third parties, including their content and links, may be constantly changing. These sites and services may have their own privacy policies and customer service policies. Browsing and interaction on any other website, including websites which have a link to our Site, is subject to that website's own terms and policies.

Compliance with Laws and Law Enforcement Requests; Protection of Our Rights:

In certain situations, we may be required to disclose personal information in response to lawful requests by public authorities, including to meet national security or law enforcement requirements. We may disclose personal information to respond to subpoenas, court orders, or legal process, or to establish or exercise our legal rights or defend against legal claims. We may also share such information if we believe it is necessary in order to investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, violations of our Service Agreement, or as otherwise required by law.

PARENTS AND CHILDREN
